AGENDA

The agenda items for the Council meeting were the following:

- (1) Update on the progress of academic collaborations, including the introduction of new certificate courses
- (2) Areas for further academic collaboration

The Council passed the minutes of the previous meeting held on May 22, 2023.

The Council was informed by the Principal, Mar Gregorios College of Law about the academic developments of the college including affiliation being sought for LLM courses in Maritime Law, Criminal Law, International Trade Law and law Relating to Artificial Intelligence and Forensics. The Council was also informed that it was formulating a minor course on law to be offered alongside the rollout of the New Education Policy.

RESOLUTIONS

The Council deliberated on new areas for collaboration and agreed upon the cooperation for the following specific activities:

- 1. Offering of a certificate course on Legal Aspects of Startups in collaboration with Legal Startups, Law Teachers India, and Mar Baselios College of Engineering and Technology. The course would be a 30-hour certificate course covering areas such as IPR, taxation, labour laws and company law.
- 2. The Council agreed that Mar Gregorios College of Law and Government Law College, Trivandrum would collaborate in the training program organized for SC/ST students aspiring to join for legal education. LLM students from MGCL would be deputed for the same.
- 3. The Council also agreed that the MGCL could take measures to establish a Consumer Awareness Cell as well as an Election Literacy Club.
- 4. The Council members agreed to participate in the International Conference on Education to be conducted by Mar Theophilos Training College in January 2024.
- 5. Mar Ivanios College agreed to cooperate with MGCL on the rollout of the course on legal aspects of startups as well as examine new avenues to offer the course on law and literature.
