### National Scholarship – Central Level

#### 1. Post Matric Scholarships Scheme for Minorities

Post Matric Scholarship for minorities is provided by the Ministry of Minority Affairs (MOMA) for the upliftment of students belonging to minority communities. According to the Government of India, Muslims, Sikhs, Christians, Buddhists, Zoroastrians (Parsis) and Jains are notified as minority communities. Under this post-matric scholarship for minorities, students studying in class 11 to PhD are offered up to INR 10,000 annually to pursue higher education.

#### 2. Post-matric Scholarship for Students with Disabilities

NSP Post Matric Scholarship for Students with Disabilities 2022-23 is an initiative for physically disabled students from Class 11 to postgraduate level. The scholarship is being offered by the Department of Empowerment of Persons with Disabilities, Government of India. The key objective of the scholarship is to support students with disabilities in their studies and prepare them to earn their livelihood and find a dignified place for themselves in society. The selected candidates will receive maintenance allowance, book grant, reimbursement of compulsory non-refundable fees and disability allowance.

## **3.** Financial Assistance for Education of the Wards of Beedi/Cine/IOMC/LSDM Workers - Post-Matric

NSP Financial Assistance for Education of the Wards of Beedi/Cine/IOMC/LSDM Workers - Post-Matric 2022-23 is an initiative for the students enrolled in Class 11 to postgraduation level at any Government institution. The scholarship is being offered by the Ministry of Labour and Employment, Government of India. The main objective of this scheme is to ensure no child is working in any hazardous sector as labour. The selected candidates will receive scholarship of up to INR 25,000 per annum.

# 4. CENTRAL SECTOR SCHEME OF SCHOLARSHIPS FOR COLLEGE AND UNIVERSITY STUDENTS

NSP Central Sector Scheme of Scholarship for College and University Students 2022-23 is an initiative of the Department of Higher Education, Ministry of Education, Government of India for Class 12 passed students who are studying in College/University. The scholarship aims to provide financial assistance to meritorious students from poor families to meet a part of their day-to-day expenses while pursuing higher studies. The selected candidates will receive scholarships of up to INR 20,000 per annum.

## 5. Prime Minister's Scholarship Scheme For Central Armed Police Forces And Assam Rifles

Prime Minister Scholarship Scheme is **specifically for the wards of serving and retired CAPF and Assam Rifles personnel undergoing first professional degree courses**. The scheme was commenced in the year 2008 and scholarship is given to the students depending upon their course of study from two to five years.

## 6. PRIME MINISTER'S SCHOLARSHIP SCHEME FOR WARDS OF STATES/UTs POLICE PERSONNEL MARTYRED DURING TERROR/NAXAL ATTACKS

Prime Minister's Scholarship Scheme for Wards of States/UTs Police Personnel 2022-23 is an initiative of the Welfare and Rehabilitation Board, Ministry of Home Affairs, Government of India for the dependent wards of State Police personnel who are martyred during Terror/Naxal attacks.

## 7. Prime Minister's Scholarship Scheme For RPF/RPSF

Prime Minister's Scholarship Scheme for RPF/RPSF 2022-23 is an initiative of the Ministry of Railways, Government of India for the wards and widows of ex-RPF/RPSF personnel. The aim of this scheme is to encourage the candidates to pursue higher technical and professional education. The selected candidates will receive a scholarship of up to INR 3,000 per month.

## 8. PG INDIRA GANDHI SCHOLARSHIP FOR SINGLE GIRL CHILD

The University Grants Commission of India is inviting online applications through the National Scholarship Portal for PG Indira Gandhi Scholarship for Girl Child. This scholarship aims at providing assistance and support to Post Graduate Students under the category of **"Single Girl Child"**. They will receive monetary incentives under this scholarship scheme.
